Our esteemed speaker also explained the scenario of expressionism film and described that before the First World War, numerous connected artistic trends in Germany that peaked in Berlin in the 1920s included the German expressionist movement in cinema. These changes were a part of a broader Expressionist movement that affected north and central European culture in areas like architecture, dance, painting, sculpture, and film. To help our students with any questions they had, we set up a question-and-answer session.





Outcome: Students came to know about the renowned

Brief description of theevent - A One day
Workshop titled "Digital

Hygiene and Understanding Misinformation" was organised by the Department of Journalism and Mass Communication, RKSMVV in collaboration with IQAC on 02/12/22. The speaker Mr. Joydeep Das Gupta was brilliant and explained beautifully how to understand the misinformation in the pool of digital media channels. Being a representative of Google Network, he mainly focused on identification of Fake news on Google. Our eminent speaker explained that false or misleading information that poses as reliable news is referred to as fake news. Fake news typically belongs to one of two categories:

• Stories that are purposefully erroneous, meaning that the authors are

aware of their falsity yet choose to publish them anyhow. This could be done to influence public opinion or increase visitors to a certain website

• Narratives with some truth to them, but largely false. This could occur from the author's



failure to verify all of their information or from their exaggeration of some details in order to support a point.

Outcomes- The Workshop was very insightful for the students. Our students obtained a lot of information from the workshop. The term "fake news" was first used in the 19th century, so students learned that misinformation is not a new phenomenon, but that its creation and dissemination have changed as a result of the internet and social media. Before the internet, news was typically obtained via reliable media outlets whose reporters had to abide by stringent ethical standards. With few editorial standards or oversight, the internet made it possible to produce, exchange, and consume news and information in new ways. Nowadays, a lot of people get their news from social media and other online sources, but it's not always simple to tell which stories are true and which are not. All the four teachers and students were present and did all the Hands-on activities enthusiastically.

Brief description of the event – A One-day Workshop titled "Understanding the Audio Landscape through Radio Talk & Radio News Script" was organised by

the department of Journalism and Mass Communication, RKSMVV in collaboration with IQAC, on 16/12/22. The speaker, eminent Radio Jockey (RJ) Smt. Chavanika Dutta Gupta was excellent in her enriched lecture. She shared her real-life experience as a RJ and did some hands -on activities with students on radio script that day. So as for the presenter to be successful, they must persuade the audience to tune in to the program. It is clear that a presenter's function becomes essential in building and sustaining a lively relationship with the listener who is not visible. Because of its baffling diversity, India is virtually always the case when the profile of the unseen listener is complex and diversified, making it even more so. The task of providing services to all social classes without discrimination or exclusion is particularly large for public service broadcasters, which makes the presenter's position even more important. She also discussed that since radio is a sound medium, radio hosts should have a pleasant, high-quality voice, command of the broadcast language or accent, clear pronunciation, good diction, confidence, and a natural flow of speech. They ought to possess "the gift of the gab," which is another term for "the ability to speak with eloquence and fluency."

Learning Outcome- Following the workshop, students will have gained an understanding of the significance of presentations, be able to recognize different types of presenters and their qualities, be able to adapt a script for



radio use, and, with enough planning and practice, create their own unique presentation style. Students came to know that since radio is a sound medium, radio hosts should have a pleasant, high-quality voice, command of the broadcast language or accent, clear pronunciation, good diction, confidence, and a natural flow of speech. They ought to possess "the gift of the gab," which is another term for "the ability to speak with eloquence and fluency". Presenters serve as the connection between the broadcasting organization and its audience, functioning as its spokespeople. The listener connects with the presenters and builds a rapport with them, even when the organization's internal hierarchy and program production team stay in the background. A presenter is something like a salesperson in that they are expected to be fully informed on the nature, substance, and tone of the program they will be presenting. All the four faculties & 34 students of this department enthusiastically participated in this fruitful workshop.



Dr. Kausik Ray, Associate Professor, Department of Journalism and Mass Communication, Dum Dum Motijheel College, gave an insightful and thought-provoking lecture on "Media and Development". In his welcome address Smt. Tanika Deb Roy introduced Assistant Prof. Kausik Ray as an eminent Media Educator and academician who has achieved laurels in the area of Development Communication, Advertising, and Sports journalism. Dr. Ray has 24 years of Experience as media educator. His informative talk and knowledge in development communication were excellent. The lecture was attended by the teachers and Even and Odd Semester (Sem 1, 4 & 6) students of our department. To help our students with any questions they had, we set up a question-and-answer session. A formal vote of thanks was proposed by Assistant Professor Aditi Das, Head of the Department, who thanked the revered speaker for delivering a thought-provoking lecture.

Learning Outcome: Dr. Kausik Ray highlighted the relevance of the topic and also talked about the transforming role of media in development communication, as it seeks social change in the direction of the higher quality of life and a socializing role, by seeking to maintain some of the established values of the society. He also threw light on the matter that in development communication, media should spread knowledge on these relevant areas: government should provide adequate food and clean drinking water, decent shelter; education; security of livelihood, help people to participate in decision making, uphold a person's dignity and self-respect and also consider the case of the high-yielding seed variety. Farmers are able to raise their crop manifold after adoption and more money will be available to purchase equipment, animals, or land as a result. Students came to know that Communication and media play a

vital role to support social development and a significant amount of social transformation is necessary. People must be educated, persuaded, and informed in order to achieve it. Information must flow both from and to them in order to meet their needs and allow them to take part in acts and decisions in nationbuilding. It also needs to move vertically in order for decisions to be made. Our eminent speaker stated that using communication for growth requires a lot of feedback. communication should never be one-way. It should be feasible for users to provide implementors meaningful feedback. He also shared some detailed information on the Basic Need Approach. He stated that Poverty is the state experienced by those who are unable to achieve their fundamental needs. The methodology comprised determining and assessing welfare outcomes and concentrated on standards of non-material needs like political liberty, employment, and participation as well as material needs like food, clothing, and shelter. Brief description of the event: An extension lecture was conducted by the Department of Journalism and Mass Communication, RKSMVV. Smt. Sahana Chatterjee, Faculty Department of Journalism and Mass Communication, Barrackpore Rastraguru Surendranath College, gave an insightful and thought-provoking lecture on "Ethical Issues in Today's Media". In her welcome address Smt. Sreejaya Chatterjee introduced Smt. Sahana Chatterjee as a freelancer for various publication in Bartaman Patrika which includes Saptahik Bortoman, Shukhi Grihokon and many more. She has been teaching since 2002. Her informative talk and knowledge in Ethical guidelines of media were excellent. The lecture was attended by the teachers and Even and Odd Semester (Sem 1, 4 & 6 hons. and general) students of our department. To help our students with any questions they had, we set up a question-and-answer session. A formal vote of thanks was proposed by Smt. Tanika Deb Roy, who thanked the revered speaker for delivering a thought-provoking lecture.

Learning Outcome: Smt. Sahana Chatterjee highlighted the relevance of the topic and also talked about the idea of **self-regulation**, which is a voluntary action

taken by media organizations as well as individual media professionals. Since it is not enforced by any outside organization, the public views it as having greater legitimacy. In the best interests of the media, its various stakeholders, and the public at large, self-regulation guarantees the freedom of the media to operate. She also threw light on the matter that Ethics is all about making personal decisions and choices; it does not entail following a formal set of rules and regulations. Rather, ethics is more about self-checking or self-control. Although laws are frequently derived from the ethical ideals of a community during a specific period, ethics is not the same as law. Legal infractions are punishable, while unethical behaviour is not. Students came to know that media practitioners should aspire to some fundamental ethical ideals that are shared by all cultures and nations, including impartiality, independence, truthfulness, fairness, accountability, and privacy. Freedom of speech and expression were acknowledged as fundamental rights after independence and were enshrined in the Indian Constitution. "All citizens shall have the right to freedom of speech and expression," reads Article 19(1)(a) of our Constitution. But there are certain restrictions that we should follow for the protection of our country because freedom is not absolute. She elaborated the relevance of the term 'Reasonable restrictions'. Students discovered that Article 19(2) of the Constitution defines "reasonable restrictions" as those that are necessary to protect the security and sovereignty of India, friendly relations with other countries, public order, decency or morality in regards to contempt of court, defamation, or incitement to commit an offence. Our department successfully handled the question-and-answer session, which helped students learn more specifically about the Ethical issues in today's media and also acquired knowledge on the certain ethical principles and norms.
