- 5) This agreement shall remain in force for 3 years if either institution does not terminate it by a minimum of six months' written notification to the other institution.
- This agreement may be extended after discussion by the 6) representatives of both institutions.
- The agreement may at any time be received or notified by mutual 7) consent within the period agreed upon by way of the clause mentioned above.
