- 3) Students of both institutions will have equal access to quality enhancement programs organized by the departments at both institutions.
- 4) It is understood that implementation of any of the types of co-operation stated in clause 3 and mentioned above shall depend upon the availability of resources and financial support at the institution concerned.
- 5) This agreement shall remain in force for 3 years if either institution does not terminate it by a minimum of six months' written notification to the other institution.
- 6) This agreement may be extended after discussion by the representatives of both institutions.
- 7) The agreement may at any time be received or notified by mutual consent within the period agreed upon by way of the clause mentioned above.
