The Academy of Research for Cultivation of Indian Sciences (ARCIS), Kolkata, a nascent research institute working across India and abroad. The present address of the institute is 4D, Aditya Apartment, 401 New Green Park, Post: Narendrapur, District: South 24 Parganas, Kolkata 700103, West Bengal.

WHEREAS:

1. **Ramakrishna Sarada Mission Vivekananda Vidyabhavan**, referred to as **RKSMVV** today stands among the premier girls' colleges of the State. It is a NAAC 'A' Grade college. 1. APPLICABILITY

This MOU is for the research work of ARCIS where

1. **RKSMVV** will provide infrastructural facilities for the Female Resource persons and scholars of **ARCIS** with the permission of using college library.
2. The students of **RKSMVV** will get a special privilege and chance to do their research work in the research unit of **ARCIS**.
3. The following courses will be conducted and certified jointly by **RKSMVV** and **ARCIS**.
 - a) Traditional Texts: Śrīmadbhagavadgītā & Mahābhārata
 - b) Philosophy of Swami Vivekananda
 - c) Thoughts of Modern Indian Thinkers
 - d) Other courses mutually decided

1. This Memorandum of Agreement will be valid for three years from the date of execution of this Agreement. After successful completion of the conditions and after expiry of this Agreement, the same may be extended on mutual consent.
