Address of its office is: 135 Jodhpur Park, Selimpur, Dhakuria, Kol – 68. It enhances the skills of the youth, especially coming from poor families and lack opportunities, by training them on soft skills and finally provides the candidates with job opportunities, so that they have the choice and control to become economically and socially empowered. It does not charge anything from the applicants.

WHEREAS:

1. **Ramakrishna Sarada Mission Vivekananda Vidyabhavan**, referred to as RKSMVV today stands among the premier girls' colleges of the State. It is a NAAC 'A' Grade College. In the 2020-21 list issued by the Education World of India's top 500 Colleges ranks as the fifth best college in West Bengal and 28th in India among nation-wide All Non-Autonomous Colleges.
2. **Magic bus India Foundation** is implementing Connect With Work (CWW) programme supported by ALSTOM, BARCLAYS aiming to provide training and placement support for freshly graduated job needy students.

4. **Magic bus India Foundation** will not take any charges from students.

5. Both '**Magic Bus India Foundation**' & **Ramakrishna Sarada Mission Vivekananda Vidyabhavan** can terminate this collaboration by giving 7 (seven) days' notice. Students admitted till then will receive support of placement assistance.

6. Any dispute arising will be mutually settled between the two signatories' of the collaboration. It cannot be taken for judicial intervention.
