**SUPPLEMENTARY AGREEMENT**

This Memorandum of Agreement, in continuation of and in addition to the Agreement executed on 16.4.2022 between Sister Nivedita University and Ramakrishna Sarada Mission Vivekananda Vidyabhavan being referred to as the Supplementary Agreement, is executed on 14.02.2023.

By and between

**Sister Nivedita University**, established under the Sister Nivedita University Act, 2017, having its campus at DG 1 /2, New Town, Kolkata-700156, represented by Prof. Suman Chatterjee, Registrar, Sister Nivedita University, hereinafter referred to as SNU, (which expression wherever the context admits or permits shall mean and include its members of the Governing Board for the time being their successors-in-interest and successors in office and assigns) of the FIRST PART

AND

**Ramakrishna Sarada Mission Vivekananda Vidyabhavan** established in 1961 having its office and institution at 33, Sree Maa Sarada Sarani, South Dumdum, Kolkata 55, represented by its authorized representative and Principal Pravrajika Vedarupaprana, hereinafter referred to as RKSMVV, (which expression wherever the context admits or permits shall mean and include its members of the Governing Board for the time being their successors-in-interest and successors in office and assigns) of the OTHER PART

Memorandum of Agreement executed between SNU and RKSMVV on 16.4.2021 may hereinafter referred to as MOAM and the Memorandum of Supplementary Agreement executed between SNU and RKSMVV on 14.02.2023 may be referred to as MOAS  
RKSMVV and SNU will hereinafter be referred to as Parties jointly and Party individually.

**Whereas**

1. RKSMVV has entered into an Agreement with SNU on 16.04.2021 to carry on various activities like vocational training with regard to courses, namely a) Public Relations and Advertising and (b) Hospital Management
2. RKSMVV and SNU intend to diversify the training on other course like c) Psychology on the same terms and conditions
3. RKSMVV and SNU may in future include other courses for the aforesaid activities on the same terms and conditions on mutually agreed decision.
4. SNU agrees to the proposal of RKSMVV

Now, therefore, this Supplementary Memorandum of Agreement is executed with the following terms and conditions:

1. Both the Parties will start the vocational training program on Psychology on the same terms and conditions as agreed upon in the MOAM executed on 16.04.2021 from a mutually agreed date.
2. *The Parties may in future may include any other course or courses for vocational training on the same terms and conditions as laid down in the Memorandum of Agreement executed on 16.04.2021*

3. All intents and purposes envisaged in the MOAM executed on 16.4.2021 are and will be applicable *mutadis mutandus* on MOAS, i.e., this Agreement.


