TERMINATION AND EXTENSION

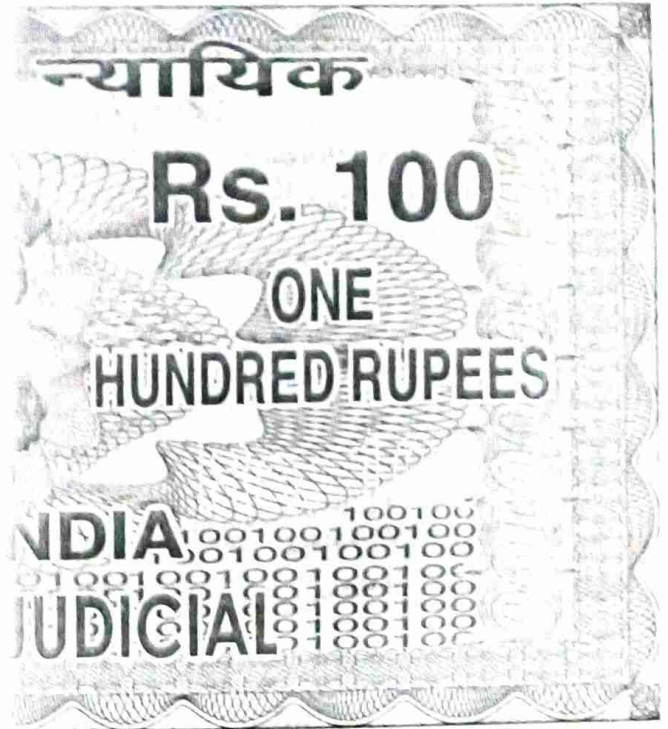
1. This agreement shall remain in force for **3 years** if either institution does not terminate it by a minimum of one month's written notification to the other institution.



And

WHEREAS:

4. SCOPE AND AREAS OF OPERATION:

- (a) The following Courses are proposed to be conducted at the College Premises (for classroom & practical session)
- (b) Usage of logo and Brand name of the associated partner organization for mobilization of candidates which would be done by College.
- (c) All necessary laboratory tools/ equipments/ aggregates/ consumables/ computers/ printers/ projector required for classroom/ practical training as per job role wise course would be made available by the Institute.
- (d) Counseling and Admission would be done jointly by College.
- (e) Training would be conducted and delivered by qualified faculty member/s & Guest Lectures of GTTI at the College premises as decided mutually according to the prescribed training delivery plan.
- (f) Assistance in placement to deserving candidates by GTTI along with lifelong placement support.

5. PURPOSE OF THIS MEMORANDUM OF UNDERSTANDING

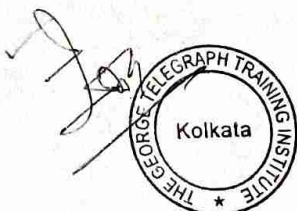
- (a) The provisions of this MoU are intended to describe the manner and extent to which the Parties will work together.
- (b) The MoU records the current level of understanding between the Parties and is a record of their intentions in respect of the issues described in this MoU.
- (c) The Parties agree that the MoU does not impose any legal liability or obligation on each Party or their respective employees, contractors, agents and advisers.
- (d) This MoU may be terminated by either Party by giving three months notice in writing to the other Party at any time.
- (e) The Parties agree that this MoU does not constitute any offer or invitation which is capable of acceptance.

6. INDEMNITY

Training Institute shall at all times during the term of the MOU and /or after the termination of the MOU defend, indemnify and hold harmless Company (and its directors, officers, agents, representatives and employees) from and against any and all claims, suits, liabilities, judgments, losses and damages arising out of or in connection with any claim or suit or demand: (i) by any illegal usage of Company's Trade Mark/ Brand Name.

7. TERMINATION

This MOU is valid till terminated by either party under mutual understanding. Either party may terminate this MOU at any time by giving ninety (90) days written notice.

Commercial and other terms of this proposed association has been formalized mutually through this agreement by both the parties for a minimum period of 03 years.

10. **TERMS OF PAYMENT:**

Students can avail installment facility as per the defined norms of the institute.

11. **AMENDMENT**



Now, therefore this memorandum of agreement is executed with the following terms and conditions.

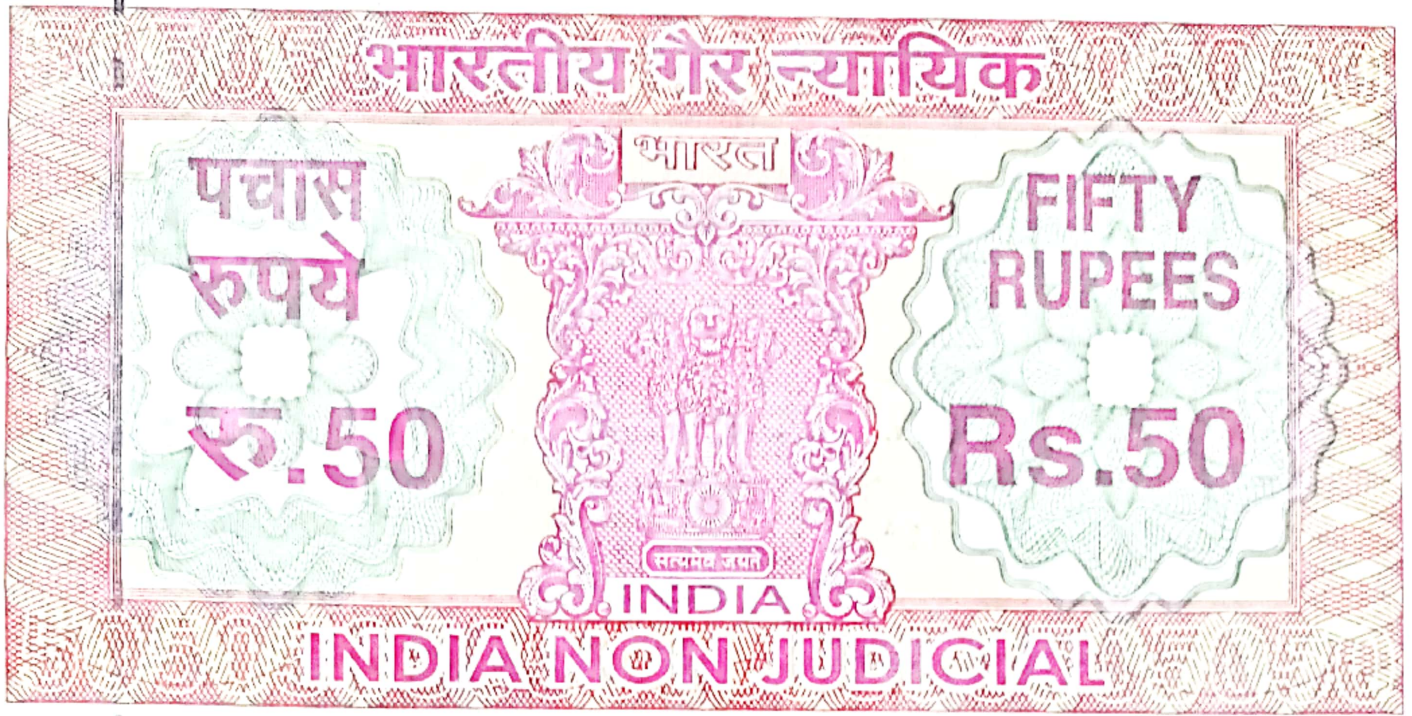
- 1) Nrityangan Sangeet Academy with provided the resource persons for imparting training in different courses namely on A) Music, B) Recitation, C) Dance.
