

No. 1684-Edn(G) dated 9th May, 1961 on the above subject, the undersigned is directed by order of the Governor to say that it has since been decided that the Ramakrishna Sarada Mission Vivekananda Vidyalayan, Dum Dum, should be treated as a specially sponsored College for Women, subject to the following terms and conditions :-

- (i) The Ramakrishna Sarada Mission, Dakshineswar will provide for the services of not less than four honorary qualified teachers (Pravrajikas), including the Principal, the Vice-Principal and two Lecturers and also certain honorary clerical staff.
- (ii) The deficit in the approved recurring expenditure of the College will be met by Government.
- (iii) The Managing Committee (Governing Body) of the College will be formed by the Mission with the approval of the Calcutta University.
- (iv) The teaching and the non-teaching posts required for the College will be sanctioned by Government.
- (v) All posts, except those held in honorary capacity by those mentioned in item (i) above, will carry the scales of pay for the respective posts approved by Government for Sponsored Colleges.
- (vi) Only persons possessing the qualifications prescribed by Government for the respective posts will be eligible for appointment to these posts.
- (vii) Appointment to teaching posts will be made by a Selection Committee composed of (1) the President - Principal of the Managing Committee (Governing Body) of the College; (2) the Secretary of the College and (3) a representative of the Director of Public Instruction, West Bengal.
- (viii) The authorities of the College will not, without the prior approval of Government, (a) initiate any action in matters requiring financial assistance - recurring or non-recurring from Government, (b) introduce any new subject or any Honours Course in an existing Pass subject, (c) grant higher initial pay to any employee of the College.

The undersigned is directed to say that in accordance with the provisions of G.O. No. 3886-Edn(G) dt. 4.11.63 the authorities of Ramakrishna Sarada Mission Vivekananda Vidyabhaban, Dum Dum were to provide honorary services of not less than four qualified teachers belonging to the monastic order of the Mission (including the Principal the Vice-Principal and two Lecturers) and certain honorary clerical staff for the College. Those employees were however, paid honorarium by the College authority @ Rs. 75/- p.m. with effect from 1961 and at a revised rate of Rs. 250/- p.m. with effect from 1974 out of the maintenance grants paid to the College without prior approval of Govt. and the number of honorary workers was also gradually raised to 13 (8 teachers including Principal and 5 non-teaching). The present number of honorary workers is now 11 (6 teachers including Principal and 5 non-teaching).

In consideration of the fact that those monastic employees are within the admissible strength of teaching and Non-teaching Staff of the College and have been working voluntarily for a long time with a fixed honorarium towards their maintenance the Governor after reconsideration of the case is pleased to approve of the payment of a maintenance allowance @ Rs. 250/- p.m. to each of those qualified monastic members of Ramakrishna Sarada Mission Vivekananda Vidyabhaban Dum Dum, who are working as teachers (including Principal) and non-teaching employees of the College on honorary basis subject to the condition that the number of such honorary workers as at present in the College and the rate of their maintenance allowance now approved should not be revised without prior approval of Government and that those honorary workers should be taken into account while determining the admissibility of teaching and non-teaching posts for the College as per prescribed norms.

This order issues with the concurrence of the Finance Department vide their U.O. No. Group 'B' 2301 dt. 14.11.84.
