Memorandum of Understanding

This Memorandum of Understanding is made on 24.06.2024, by and between:

Ramakrishna Sarada Mission- Vivekananda Vidyabhavan (RKSMVV), 33 Sri Maa Sarada Sarani, South Dum Dum Kolkata 700055, affiliated to the West Bengal State University

And

Folk is a social enterprise committed to livelihood generation and entrepreneurship development, with premises at 1B & C, Maniktala Industrial Estate, Kolkata 700054.

Purpose: The purpose of this MoU is to establish a collaborative relationship between RKSMVV and Folk to provide students with opportunities for internships and trainings, thereby enhancing their educational experience and preparing them for professional careers.

Scope of the Agreement:

1. Internship and Training Opportunities:

Folk agrees to provide short-term internships and training opportunities to students (in relevant fields of study) of RKSMVV.

RKSMVV will identify and recommend suitable students for such opportunities.

2. Duration and Schedule:

The duration and schedule of internships and training programs will be mutually agreed upon by RKSMVV and Folk.

3. Responsibilities of RKSMVV:

The College will promote the internship and training opportunities to students and encourage their participation.

RKSMVV will ensure that selected students meet the eligibility criteria and academic requirements.

RKSMVV will provide necessary documentation and support to facilitate the internship and training programs.

4. Responsibilities of Folk:

Folk will assign a supervisor/mentor to the group of interns to provide guidance and monitor their progress.

Regular evaluations and feedback sessions will be conducted to assess the performance and learning outcomes of the interns.

Folk will provide a safe and conducive work environment for the interns.

Folk will offer meaningful and relevant work assignments to the interns and will provide necessary resources, tools, and training to support the interns' professional development.

The Company will issue certificates of completion or other relevant documentation upon successful completion of the internship/training.

5. Duration of the MoU:

This MoU will remain in effect for a period of three years from the date of signing.

Either party may terminate this MoU with one month's written notice to the other party.

The terms of this MoU may be extended beyond three years with consent from both parties.
