This Memorandum of Understanding signed on this day of March 2025 at Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College

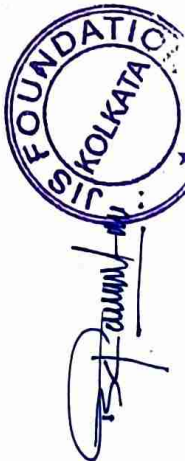
Between

And

Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College having its campus at 33, Sri Maa Sarada Sarani (Previously Nayapatty), South Dum Dum, Kolkata, West Bengal 700055 (herein referred to as Ramakrishna Sarada Mission) is to fulfil the following objectives as outlined below, and the responsibilities of both the parties, as mutually agreed upon.

As per the discussion held between Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College and JISD, the parties have jointly agreed to work upon various Training Programmes and would share the responsibilities as per the terms expressly provided hereunder.

JISD will draw upon the strengths of Ramakrishna Sarada Mission which would primarily focus be focused on Training Infrastructure and Mobilization of Students for UTKARSH Bangla Project PBSSD .

NOW THEREFORE, Ramakrishna Sarada Mission and JISD have come together to record their intentions through this Memorandum of Understanding (MOU) and with the following responsibilities by the parties to the MOU:

RESPONSIBILITIES – JISD

1. JISD will be responsible for overall Execution of the Training Program at Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College.
2. JISD will appoint the adequate manpower to execute the Training Program at Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College.
3. JISD will be responsible for Assessment & Certification to the successful students.
4. JISD will be providing Placement Assistance as per the availability of the Job Openings across PAN India to the successfully assessed and eligible (18 years of age, willing to relocate as per the job location) candidates after successful completion of the training program.
5. JISD will be responsible for overall operations of the Skill Training Centre at Ramkrishna Sarada Mission Vivekananda Vidyabhavan Girls' College.
6. JISD will be running the following Trades initially in the Skill Training Centre at at Ramkrishna Sarada Mission Vivekananda Vidyabhavan Girls' College -

RESPONSIBILITIES – Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College

1) Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College will be responsible for providing the following adequate Infrastructure in order to execute the Skill Development Training Program at their College Campus –

- a) Class Room (2 Nos)
- b) IT Lab (2 Nos)
- c) Staff Room (For trainers)

2) Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College will initiate the Students Enrolment related Activities in the College.

3) Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College will be responsible for proper Capacity utilization of the Skill Development Training Centre.

TENURE -

The MOU shall remain valid for a period of 1 years (12 Months) from the date of signing MOU or 15 March 2026 whichever is earlier. The MOU can however be cancelled by mutual consent "However, in case of cancellation, both the parties will ensure successful completion of ongoing programs".

This Memorandum of Understanding comes into effect from the date hereinabove provided. Based on this Memorandum of Understanding, Ramakrishna Sarada Mission Vivekananda Vidyabhavan Girls' College and JISD officials will work out the detailed modalities of the project and take it forward for implementation immediately.
